Introduction

The SRA, through the Law Society, is a designated professional body under Part 20 of FSMA. This means that firms (including sole practices) authorised by us may carry on certain regulated financial services activities without being regulated by the FCA if they can meet the conditions in section 327 of FSMA.

The SRA Financial Services (Scope) Rules set out the scope of the regulated financial services activities that may be undertaken by firms authorised by us and not regulated by the FCA. These rules regulate the way in which firms carry on such exempt regulated financial services activities and the way in which firms that are dually regulated by us and the FCA carry on their non-mainstream regulated activities.

These rules do not apply to solicitors, RELs, RFLs and RSLs practising outside firms that are authorised by us.

This introduction does not form part of the SRA Financial Services (Conduct of Business) Rules.

- 1. Apart from rule 2 (Status Disclosure), these rules apply to:
 - 1. <u>authorised bodies [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]</u> which are not regulated by the <u>FCA [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FCA]</u>:
 - 2. <u>authorised bodies [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body]</u> which are regulated by the <u>FCA [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FCA]</u>, but only in respect of their <u>non-mainstream regulated activities</u>

- 2. Rule 2 applies only to <u>authorised bodies</u>

Rule 2: Status disclosure

- 2. Notwithstanding the wider information obligations in the <u>SRA Codes of Conduct [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#SRA-Codes-of-Conduct]</u>, you must give the <u>client [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> the following information in writing in a manner that is clear, fair and not misleading before providing a service which includes the carrying on of a <u>regulated financial services activity</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#regulated-financial-services-activities] and in good time before the conclusion of a <u>contract of insurance [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#contract-of-insurance]</u>:
 - 2. a statement that you are not authorised by the <u>FCA</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FCA];
 - 3. your name and practising address:
 - 4. the nature of the <u>regulated financial services activities</u>

- 5. a statement that you are authorised and regulated by the <u>SRA</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]; and
- 6. a statement explaining that complaints and redress mechanisms are provided through the <u>SRA</u>

- 3. Before you provide a service, which includes the carrying on of an insurance distribution activity [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#insurance-distribution-activity] with or for a client [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] and in good time before the conclusion of a contract of insurance [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#contract-of-insurance], you must state that you are an ancillary insurance intermediary [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#ancillary-insurance-intermediary] and make the following statement in writing to the client [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] in a way that is clear, fair and not misleading:

"[This firm is]/[We are] not authorised by the Financial Conduct Authority. However, we are included on the register maintained by the Financial Conduct Authority so that we can carry on insurance distribution activity, which is broadly the advising on, selling and administration of insurance contracts. This part of our business, including arrangements for complaints or redress if something goes wrong, is regulated by the Solicitors Regulation Authority. The register can be accessed via the Financial Conduct Authority website at www.fca.org.uk/firms/financial-services-register."

Rule 3: Execution of transactions

3. You must ensure that where you have agreed or decided in your discretion to effect a transaction
transaction, you must do so as soon as possible, unless you reasonably believe that it is in the client's lhttps://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] best interests not to.

- 4. Where you receive instructions from a <u>client</u>

 record of:
 - 4. the name of the <u>client [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u>;
 - 5. the terms of the instructions or decision; and
 - 6. in the case of instructions, the date on which they were received.
- 5. Where you give instructions to another person to effect a <u>transaction [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#transaction]</u>, you must keep a record of:
 - 4. the name of the <u>client[https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u>;
 - 5. the terms of the instructions;
 - 6. the date on which the instructions were given; and
 - 7. the name of the other person instructed.

- 5. Where you receive commission which is attributable to your regulated financial services activities

 - 5. the amount of the commission; and
 - 6. how you have accounted to the <u>client</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client].

Rule 6: Safekeeping of clients' investments

- 6. Where you undertake the <u>regulated financial services activity</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#regulated-financial-services-activities] of safeguarding and administering investments, you must operate appropriate systems, including the keeping of appropriate records, which provide for the safekeeping of <u>assets [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#asset]</u> entrusted to you by <u>clients [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> and others.
- 7. Where such <u>assets [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#asset]</u> are passed to a third party:

- 6. you should obtain an acknowledgement of receipt of the property; and
- 7. if they have been passed to a third party on the <u>client's</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] instructions, you should obtain such instructions in writing.

If you arrange for a <u>client [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> on an <u>execution-only</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#execution-only] basis any <u>transaction [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#transaction] involving a retail investment product [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#retail-investment-product], you must send the <u>client</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] written confirmation to the effect that:</u>
 - 7. the <u>client [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> had not sought and was not given any advice from you in connection with the <u>transaction</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#transaction]; Or
 - 8. the client [https://referral.sra.org.uk/solicitors/standardsregulations/glossary/#client] was given advice from you in
 connection with that transaction

 wishing the transaction [https://referral.sra.org.uk/solicitors/standardsregulations/glossary/#transaction] to be effected,

and in either case the <u>transaction [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#transaction]</u> is effected on the <u>client's [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> explicit instructions.

Rule 9: Communication and disclosure

- 9. You must ensure that, in relation to <u>insurance distribution</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#insurance-distribution]:
 - 9. you communicate all information, including marketing communications, in a way that is clear, fair and not misleading.
 - 10. your marketing communications are always clearly identifiable as such.

Rule 10: General information to be provided

- 10. In good time before the conclusion of a <u>contract of insurance</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#contract-of-insurance], you must disclose the following information to <u>clients</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]:
 - 10. whether you provide a <u>personal recommendation</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#personal-recommendation] about the insurance products offered;
 - 11. the procedures allowing <u>clients</u>

- 11. Where you propose, or give a <u>client</u>

 - 11. give a <u>personal recommendation</u>
 [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#personal-recommendation] on the basis of a fair and personal analysis;
 - 12. are under a contractual obligation to conduct <u>insurance</u> <u>distribution [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#insurance-distribution]</u> exclusively with one or more <u>insurance undertakings</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#insurance-undertaking], in which case you must provide the names of those <u>insurance undertakings [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#insurance-undertaking]</u>; Or
 - 13. are not under a contractual obligation to conduct <u>insurance</u> <u>distribution [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#insurance-distribution]</u> exclusively with one or more <u>insurance undertakings</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#insurance-undertaking] and do not give advice on the basis of a fair and personal analysis, in which case you must provide the names of the <u>insurance undertakings</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#insurance-undertaking] with which you may and do conduct business.
- 12. If you inform a <u>client [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> that you give a <u>personal recommendation [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#personal-recommendation]</u> on the basis of a fair and personal analysis:
 - 11. you must give that personal recommendation on the basis of an analysis of a sufficiently large number of insurance contracts available on the market to enable it to make that recommendation; and
 - 12. that personal recommendation must be in accordance with professional criteria regarding which contract of insurance would be adequate to meet the client's needs.

- 12. Prior to the conclusion of a <u>contract of insurance</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#contract-of-insurance], you must specify on the basis of information obtained from the <u>client [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u>, the demands and needs of that <u>client [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u>.
- 13. The details must be adapted according to the complexity of the contract of insurance [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#contract-of-insurance]_proposed and the individual circumstances of the client [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client].
- 14. You must give the <u>client [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> a statement of the <u>client's [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> demands and needs prior to the conclusion of a <u>contract of insurance [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#contract-of-insurance]</u>.
- 15. Any contract of insurance [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#contract-of-insurance] proposed by you must be consistent with the client's [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] demands and needs and where you have given a personal recommendation [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#personal-recommendation] to the client [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client], you must, in addition to the statement of the demands and needs, provide the client [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] with a personalised explanation of why a particular contract of insurance [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#contract-of-insurance] would best meet the client's [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] demands and needs.

Rule 13: Use of intermediaries

- 13. You must not use, or propose to use, the services of another <u>person</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#person] consisting of:
 - 13. <u>insurance distribution [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#insurance-distribution]</u>;
 - 14. <u>reinsurance distribution [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#reinsurance-distribution]</u>;
 - 15. <u>insurance distribution activity</u>
 [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#insurance-distribution-activity]; Or

16. home finance mediation activity

- 4. in relation to https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#home-finance-mediation-activity], is not carrying on this activity in the UK]

Before using the services of the intermediary, you must check the <u>Financial Services Register [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#Financial-Services-Register]</u> and use the services of that person only if the relevant register indicates that the person is registered for that purpose.

Rule 14: Treating complaints fairly

14. Notwithstanding your complaints handling obligations in the <u>SRA Code of Conduct for Firms [https://referral.sra.org.uk/solicitors/standards-regulations/code-conduct-firms/]</u>, you must have in place and operate appropriate and effective procedures for registering and responding to complaints from a person who is not a <u>client</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client].

Rule 15: Remuneration and the client's best interests

15. You must not:

- 15. be <u>remunerated [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#remuneration]</u>; **Or**
- 16. remunerate [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#remuneration] or assess the performance of the firm's employees [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#employee],

in a way that conflicts with their duty to act in each <u>client's</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] best interest.

16. In particular, you must not make any arrangement by way of remuneration [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#remuneration], sales target or otherwise that could provide an incentive to the firm or its employees [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#employee]_to recommend a particular contract of insurance [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#contract-of-insurance]_to a Client [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]_when it could offer a different contract of insurance [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#contract-of-insurance]_which would better meet its Client's [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] needs.

Rule 16: Remuneration disclosure

- 16. In good time before the conclusion of the initial <u>contract of insurance [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#contract-of-insurance]</u> and if necessary, on its amendment or renewal, you must provide the <u>client [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> with information:
 - 16. on the nature of the <u>remuneration</u>
 [https://referral.sra.org.uk/solicitors/standardsregulations/glossary/#remuneration] received in relation to the
 <u>contract of insurance [https://referral.sra.org.uk/solicitors/standardsregulations/glossary/#contract-of-insurance]</u>;
 - 17. about whether in relation to the contract you work on the basis of:
 - 16. a fee, that is <u>remuneration</u>
 [https://referral.sra.org.uk/solicitors/standardsregulations/glossary/#remuneration] paid directly by the <u>client</u>
 [https://referral.sra.org.uk/solicitors/standardsregulations/glossary/#client];
 - 17. a commission of any kind, that is <u>remuneration</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#remuneration] included in the premium;

- 18. any other type of remuneration
 lhttps://referral.sra.org.uk/solicitors/standards-regulations/glossary/#remuneration], including an economic benefit of any kind offered or given in connection with the contract: or
- 19. a combination of any type of <u>remuneration</u>

Rule 17: Fee disclosure: additional requirements

- 17. Where a fee is payable, you must inform the client
 [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] of the amount of the fee before the client
 [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] incurs liability to pay the fee, or before conclusion of the contract-of-insurance [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#contract-of-insurance], whichever is earlier.
- 18. To the extent that it is not possible for the amount in rule 17.1 to be given, you must give the <u>client</u>

 [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] the basis for its calculation.
- 19. This rule applies to all such fees that may be charged during the life of the <u>policy [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#policy]</u>.

Rule 18: Means of communication to clients
