Introduction

The SRA, through the Law Society, is a designated professional body under Part 20 of FSMA. This means that firms (including sole practices) authorised by us may carry on certain regulated financial services activities without being regulated by the FCA if they can meet the conditions in section 327 of FSMA. The purpose of these rules is to set out the scope of the regulated financial services activities that may be undertaken by firms authorised by us and not regulated by the FCA.

These rules do not apply to solicitors, RELs, RFLs or RSLs practising outside firms authorised by us.

This introduction does not form part of the SRA Financial Services (Scope) Rules.

These rules apply to [authorised bodies](#) [\[https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body\]](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#authorised-body) that are not regulated by the [FCA](#) [\[https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FCA\]](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FCA), their [managers](#) [\[https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#manager\]](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#manager) and [employees](#) [\[https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#employee\]](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#employee) and references to "you" in these rules should be read accordingly.

2. If you carry on any [regulated financial services activities](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#regulated-financial-services-activities) [\[https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#regulated-financial-services-activities\]](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#regulated-financial-services-activities) you must ensure that:
 2. you satisfy the conditions in section 327(2) to (5) of [FSMA](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FSMA) [\[https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FSMA\]](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FSMA);
 3. the activities arise out of, or are complementary to, the provision of a particular [professional service](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#professional-service) [\[https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#professional-service\]](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#professional-service) to a particular [client](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client) [\[https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client\]](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client);
 4. there is not in force any order or direction of the [FCA](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FCA) [\[https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FCA\]](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FCA) under sections 328 or 329 of [FSMA](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FSMA) [\[https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FSMA\]](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FSMA) which prevents you from carrying on the activities; and

3. You must not carry on, or agree to carry on, any of the following activities:
 3. an activity that is specified in an order made under section 327(6) of [FSMA](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FSMA) [\[https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FSMA\]](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#FSMA);

4. You must not act as any of the following:
 4. sponsor to an issue in respect of [securities](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#security) [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#security] to be admitted for dealing on the London Stock Exchange;
 5. nominated adviser to an issue in respect of [securities](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#security) [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#security] to be admitted for dealing on the Alternative Investment Market of the London Stock Exchange; or
 6. corporate adviser to an issue in respect of [securities](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#security) [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#security] to be admitted for dealing on the ICAP Securities and Derivatives Exchange or any similar exchange.

Rule 5: Insurance distribution activities

5. You may only carry on [insurance distribution activities](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#insurance-distribution-activity) [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#insurance-distribution-activity] as an [ancillary insurance intermediary](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#ancillary-insurance-intermediary) [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#ancillary-insurance-intermediary].



6. Rule 5.3 does not apply to you if you have been registered in the [Financial Services Register](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#Financial-Services-Register) [\[https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#Financial-Services-Register\]](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#Financial-Services-Register) and are able to carry on insurance mediation activities before 1 October 2018.

You must not enter into any transaction with a [client](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client) [\[https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client\]](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client) in which you:

7. You must not:
6. enter into a [regulated credit agreement](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#regulated-credit-agreement) as lender; or
7. exercise, or have the right to exercise, the lender's rights and duties under a [regulated credit agreement](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#regulated-credit-agreement), which is secured on land by a [legal or equitable mortgage](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#legal-or-equitable-mortgage).
8. You must not:
6. enter into a [regulated credit agreement](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#regulated-credit-agreement) as lender; or
7. exercise, or have the right to exercise, the lender's rights and duties under a [regulated credit agreement](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#regulated-credit-agreement), which includes a variable rate of interest.
9. You must not provide a [debt management plan](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#debt-management-plan) to a [client](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client).
10. You must not charge a separate fee for, or attribute any element of your fees to, [credit broking](https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#credit-broking) services.
