Introduction

The Code of Conduct describes the standards of professionalism that we, the SRA, and the public expect of individuals (solicitors, registered European lawyers, registered foreign lawyers and registered Swiss lawyers) authorised by us to provide legal services.

They apply to conduct and behaviour relating to your practice, and comprise a framework for ethical and competent practice which applies irrespective of your role or the environment or organisation in which you work (subject to the Overseas Rules which apply to your practice overseas); although paragraphs 8.1 to 8.11 apply only when you are providing your services to the public or a section of the public.

Conduct does not need to take place in a workplace in order to relate to your practice - these requirements capture conduct which touches realistically upon your practice of the profession, in a way that is demonstrably relevant.

You must exercise your judgement in applying these standards to the situations you are in and deciding on a course of action, bearing in mind your role and responsibilities, areas of practice, and the nature of your clients (which in an in house context will generally include your employer and may include other persons or groups within or outside your employer organisation).

You are personally accountable for compliance with this Code - and our other regulatory requirements that apply to you - and must always be prepared to justify your decisions and actions.

A serious failure to meet our standards or a serious breach of our regulatory requirements may result in our taking regulatory action against you. A failure or breach may be serious either in isolation or because it comprises a persistent or concerning pattern of behaviour. In addition to the regulatory requirements set by us in our Codes, Principles and our rules and regulations, we directly monitor and enforce the requirements relating to referral fees set out in section 56 of the Legal Aid, Sentencing and Punishment of Offenders Act 2012, and provisions relating to anti money laundering and counter terrorist financing, as <u>set</u>



out in regulations made by the Treasury [http://www.legislation.gov.uk/uksi/2017/692/made] as in force from time to time.

All these requirements are underpinned by our Enforcement Strategy. That strategy explains in more detail our views about the issues we consider to be serious, and our approach to taking regulatory action in the public interest.

- 2. You do not misuse or tamper with evidence or attempt to do so.
- 3. You do not seek to influence the substance of evidence, including generating false evidence or persuading witnesses to change their evidence.
- 4. You do not provide or offer to provide any benefit to witnesses dependent upon the nature of their evidence or the outcome of the case.
- 5. You only make assertions or put forward statements, representations or submissions to the <u>court</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#court] Or others which are properly arguable.
- 6. You do not place yourself in contempt of <u>court</u>

- 7. Where you supervise or manage others providing legal services:
 - 1. you remain accountable for the work carried out through them; and

- 8. You ensure that the individuals you manage are competent to carry out their role, and keep their professional knowledge and skills, as well as understanding of their legal, ethical and regulatory obligations, up to date.

 - 1. the <u>clients [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> have a <u>substantially common interest [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#substantially-common-interest]</u> in relation to the matter or the aspect of it, as appropriate; or

You keep the affairs of current and former <u>clients</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] confidential unless disclosure is required or permitted by law or the client [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] consents.
- 7. Where you are acting for a <u>client</u>

- 7. You keep up to date with and follow the law and regulation governing the way you work.
- 8. You are able to justify your decisions and actions in order to demonstrate compliance with your obligations under the <u>SRA's regulatory arrangements [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#regulatory-arrangements]</u>.
- 9. You cooperate with the <u>SRA [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u>, other regulators, ombudsmen, and those bodies with a role overseeing and supervising the delivery of, or investigating concerns in relation to, legal services.
- 10. You respond promptly to the <u>SRA</u>
 [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] and:
 - 1. provide full and accurate explanations, information and documents in response to any request or requirement; and

- ensure that relevant information which is held by you, or by third parties carrying out functions on your behalf which are critical to the delivery of your legal services, is available for inspection by the <u>SRA [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u>.
- 11. You do not attempt to prevent anyone from providing information to the <u>SRA [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> or any other body exercising regulatory, supervisory, investigatory or prosecutory functions in the public interest.
- 12. You notify the <u>SRA [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> promptly if:
 - 1. you are subject to any criminal charge, conviction or caution, subject to the Rehabilitation of Offenders Act 1974;
 - 2. a <u>relevant insolvency event</u>
 [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#relevant-insolvency-event] occurs in relation to you; or
 - 3. if you become aware:
 - i. of any material changes to information previously provided to the <u>SRA [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u>, by you or on your behalf, about you or your practice, including any change to information recorded in the <u>register</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#register]; and
 - ii. that information provided to the <u>SRA</u> [https://referral.sra.org.uk/solicitors/standardsregulations/glossary/#SRA], by you or on your behalf, about you or your practice is or may be false, misleading, incomplete or inaccurate.
- 13. You report promptly to the SRA [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] or another approved regulator [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#approved-regulator], as appropriate, any facts or matters that you reasonably believe are capable of amounting to a serious breach of their regulatory arrangements [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#regulatory-arrangements] by any person [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#person] regulated by them (including you).
- 14. Notwithstanding paragraph 7.7, you inform the SRA
 <a href="Inttps://referral.sra.org.uk/solicitors/standards-regulations/glossary/#SRA] promptly of any facts or matters that you reasonably believe should be brought to its attention in order that it may investigate whether a serious breach of its regulatory arrangements

- 15. You do not subject any <u>person [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#person]</u> to detrimental treatment for making or proposing to make a report or providing or proposing to provide information based on a reasonably held belief under paragraph 7.7

- or 7.8 above, or paragraph 3.9, 3.10, 9.1(d) or (e) or 9.2(b) or (c) of the SRA Code of Conduct for Firms, irrespective of whether the <u>SRA [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> or another approved regulator subsequently investigates or takes any action in relation to the facts or matters in question.
- 16. You act promptly to take any remedial action requested by the <u>SRA</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]. If requested to do so by the <u>SRA [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#SRA]</u> you investigate whether there have been any serious breaches that should be reported to the <u>SRA</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#SRA].
- 17. You are honest and open with <u>clients</u>

- 8. You ensure that, as appropriate in the circumstances, you either establish and maintain, or participate in, a procedure for handling complaints in relation to the legal services you provide.
- 9. You ensure that <u>clients [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client]</u> are informed in writing at the time of engagement about:
 - 1. their right to complain to you about your services and your charges;
 - 2. how a complaint can be made and to whom; and
 - 3. any right they have to make a complaint to the <u>Legal</u> <u>Ombudsman [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#Legal-Ombudsman]</u> and when they can make any such complaint.
- 10. You ensure that when clients [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] have made a complaint to you, if this has not been resolved to the client's
 [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#client] satisfaction within 8 weeks following the making of a complaint they are informed, in writing:
 - 1. of any right they have to complain to the <u>Legal Ombudsman</u> [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#Legal-Ombudsman [https://referral.sra.org.uk/solicitors/standards-regulations/glossary/#Legal-Ombudsman]; and
 - 2. if a complaint has been brought and your complaints procedure has been exhausted:
 - 1. that you cannot settle the complaint;
 - 2. of the name and website address of an alternative dispute resolution (ADR) approved body which would be competent to deal with the complaint; and
 - 3. whether you agree to use the scheme operated by that body.
- 11. You ensure that complaints are dealt with promptly, fairly, and free of charge.
